The School awards Scholarship/Freeship to needy students on Merit-cum-Means basis. Application on prescribed forms for grant of Scholarship/Freeship for the current session i.e. 2024-25 are invited from the students who fulfill the following criteria:-

- 1. The Gross Annual income of parents (both father and mother) from all sources should not exceed Rs. 2 lacs per annum. Last year's income tax return must be submitted along with the application.
- 2. Academically, minimum grade in each main subject in the previous class result must be:
 - (i) Class-I to Class V minimum grade should be A1 (91%).
 - (ii) Class VI to Class XI grade should be B1 (71%).
- 3. If there are two applicants (in case of sibling) from a family, only one child will be considered for freeship.
- 4. Consideration will be given for single mother /widow/ separated mother with legal proofs subject to fulfillment of above mentioned criteria.
- 5. Valid residence proof is mandatory.(e.g. Voter ID/Passport/Electricity Bill/ MTNL Bill but not Aadhar Card.)
- 6. The minimum attendance of applicant to be eligible for freeship should be 75% in the previous academic year.
- 7. The applicant will not be considered for freeship in case he/she is involved in any act of gross indiscipline.
- 8. There should not be any outstanding/pending dues upto the academic year 2023-24.
- 9. In case the applicant belongs to sports category the following points to be considered:
 - (i) Minimum grade B2 (61%) in all subjects
 - (ii) Level of sport State/National/International
 - (iii) Attendance Minimum 60%

Application Forms can be downloaded from the School's website. The duly filled/signed form alongwith requisite documents can be submitted at School's Gate No. 4 or to Mr. Vikram(V.P (Admin office) for class VI-XII and Ms. Kiran Mehta for Classes Nursery to V through their respective class teacher from 21/05/2024 to 31/05/2024. No Application Forms will be accepted thereafter.

Incomplete forms will not be accepted/entertained. The Scholarship Committee will consider the applications based on the scholarship criteria and award Scholarship accordingly. The list of students who will be awarded Scholarship will be available after the decision of the Scholarship/Freeship Committee.

The Scholarship Committee reserves the right to award or not to award scholarship to any student.
