We are delighted to announce that DPS Mathura Road is introducing **Horse Riding** as an optional, extracurricular activity for students of classes VI to XII starting from April 1st, 2026. Horse Riding is a wonderful activity that helps children build confidence, improve balance, posture and develop a sense of responsibility and empathy towards animals.

We have partnered with certified and experienced instructors to train the students in a safe and structured environment.

Program Details are as follows:

- **Duration** : 3 Months [April'26 – June'26]
- **Frequency** : 4 days a week
- **Age Group** : Classes VI to -XII
- **Course Fee** : ₹30,000 for the 3-month course (includes coaching and horse hiring)

Important Information Regarding Kit:

Please note that for safety reasons, specialized riding gear is mandatory. The cost of the riding kit (Helmet, Breeches/Riding Pants and Riding Boots) is **not included in the fee** and will be arranged by the parents.

Safety Protocols & Guidelines:

The safety of our students is our top priority. The following protocols will be strictly adhered to:

1. **Mandatory Equipment:** No student will be allowed to ride without a certified safety helmet, riding boots, and appropriate attire.
2. **Trained Instructors:** A qualified instructor will accompany students at all times with a low student-to-horse ratio to ensure focused attention.
3. **Horse Safety:** Only well-trained, calm horses suited for beginners will be used.
4. **Pre-requisite:** Parents must ensure that their child is comfortable around animals and will disclose any allergies (e.g., animal hair/hay) or medical conditions (e.g., back issues) prior to enrolment.
